2020/21 SEASON PASS TERMS & CONDITIONS

NYS Olympic Regional Development Authority (ORDA)

ORDA manages and operates Whiteface, Gore, Belleayre, and the Lake Placid Olympic Sites.

"SKI3 Card" is the term used to identify the "RFID enabled card" which provides access to ORDA ski lifts via a gate system. This is only the name of the card itself. Access to ORDA ski lifts is determined by the products purchased by the customer and loaded onto these "SKI3 Cards" (lift tickets, season passes, etc.). You may have a SKI3 Card that is valid at all three mountains or you may have a SKI3 Card that is limited and only valid at one mountain as an example.

The mountain from which you purchase your season pass (either in person, by mail, or online) will be considered your "Home Mountain" and referred to as such throughout the terms of this agreement. For reporting lost or stolen cards, transactional questions, or general questions governing your pass, please communicate directly with your Home Mountain.

Terms and Conditions of Purchase:

1. **All purchases are final:** Future promotions are independent of this offering. **NO refunds** for any reason, including but not limited to: sickness, injuries, relocation, health problems, weather conditions, man-made or natural disasters.
2. Whiteface, Gore, and Belleayre reserve the right to change opening and closing dates, operating hours, number of days in the week open, restrict access to any open lift and/or terrain at any time based on weather, snow, crowds, special events or any other condition or reason. Whiteface, Gore, and Belleayre also reserve the right to determine the number of lifts in operation or area available for use at any given time based on snow, weather or other condition or reasons. A minimum number of operating days is not guaranteed.
3. Season passes are non-transferable and are for the pass holder's exclusive use only. Any fraudulent use will result in the season pass being revoked.
4. Age at time of purchase will determine eligibility for all passes except the 70+ pass; customers turning age 70 during the 2020 calendar year may purchase in advance of their birthday and remain eligible for the 70+ pass. Proof of age required.
5. For full-time college students, ORDA uses a national database of college enrollment status to verify enrollment status. If your school is not represented in the database, you will be contacted via phone or e-mail to request verification of your status as a full-time student.
6. You may choose to keep your existing photo (from the 2019/20 season) or upload a new season pass photo when purchasing online, or you may update your pass photo in person at your Home Mountain. Your Home Mountain, at its discretion, can request that a new photo be taken.
A RFID-enabled SKI3 Card will be issued or reloaded for each season pass purchased. This SKI3 CARD serves as your permanent lift ticket for the season. Your SKI3 Card must be secured on your person and in a location that can be read by the gates for every lift boarding occasion. It is recommended that your pass be placed somewhere between waist height and shoulder height (or on helmet for children). Do not place your SKI3 Card in a wallet or near a cell phone; this will prevent the RFID card from being read properly.
7. If your SKI3 Card is lost or stolen, you must notify your Home Mountain at once. A replacement fee will be charged to process a new SKI3 Card.
8. Limited or restricted season passes are not valid during the following blackout periods:
December 25, 2020 - January 1, 2021, January 16 -18, 2021, and February 13-21, 2021.
9. Ski area regulations are enforced in accordance with the New York State General Obligations Law, Article 18 and 12 NYCRR Part 54, "Safety In Skiing Code." Any misuse, fraudulent use, misconduct or nuisance caused by the passholder or failure to follow New York State law may result in revocation without refund or other considerations. Whiteface, Gore, or Belleayre management reserve the right to revoke season passes depending upon the severity of the infractions.
10. All pass purchasers must sign the Season Pass Terms & Conditions digitally through the Risk waiver system before receipt and/or use of Season Pass. If purchasing online, a signature is required on the Season Pass Terms & Conditions, which is presented immediately following completion of your payment. If purchaser does not have access to the internet, the Home Mountain will provide access to a digital device where the purchaser can sign the Season Pass Terms & Conditions in person at the Home Mountain. Persons under age 18 must have a parent or legal guardian digitally sign the Season Pass Terms & Conditions.
11. **All dates, rates, and provisions are subject to change without notice.**

Photograph and Other Likeness Consent Release

I grant to the NYS Olympic Regional Development Authority (ORDA), their successors, assigns, or employees, the right to use my name and any likeness of me and/or of my minor or custodial children captured during my use of a season pass at Whiteface, Gore, Belleayre, or the Lake Placid Olympic Sites for any purpose, including advertising, trade, exhibition, publication or promotion in print and online, commercial and non-commercial. "My likeness" includes a photograph, video recording, film or artistic rendering of me, a recording of my voice, and/or reproductions of any of these. I agree that the actual material involved, such as a photograph, negative, plate, video recording, film or audio recording, is and shall be the property of ORDA.

I understand and agree that I will not be compensated in any way for the use of my/our name or any likeness by ORDA, and I hereby waive all claims to any fees or other considerations or remuneration for use of my/our name and/or likeness regardless of their realized potential commercial value, and release ORDA, their employees, agents and assigns from all claims and liability relating to said use.

Assumption of Risk Agreement

NOTICE: SKIERS AND SKI LIFT PASSENGERS - are governed by the New York State General Obligations Law, Article 18 and 12 NYCRR Part 54, "Safety In Skiing Code." Before use of your season pass, your attention is directed to the posted "Warning To Skiers" which is displayed at the base of all lifts. New York Law requires you to seek out, read, review and understand the "Warning to Skiers" before you decide to participate in the sport of skiing.

WARNING TO SKIERS: I understand the Winter Activities involve numerous risks including, but not limited to, the risks posed by variations in terrain and snow conditions, surface and subsurface snow conditions, icy or firm snow, unmarked obstacles, thin snow cover, bare spots, bumps, moguls, stumps, forest growth and debris, erosion control devices, rocks, cliffs, steep terrain, deep snow, avalanches and other hazards. I also understand Skiing and Snowboarding involve risks posed by loss of balance, loss of control, falling, sliding, collisions with other skiers or snowboarders and collisions with natural and man-made objects, including trees, rocks, fences, posts, lift towers, snow making equipment, snowmobiles and other over-snow vehicles; and other participants. I acknowledge that it is up to me and/or my child or dependent to have the physical dexterity and knowledge to safely load, ride and unload a lift, and that my child and/or dependent may use lifts without an adult present. I further agree that all of these risks and dangers are necessary to the sports of Skiing, Snowboarding and the Winter Activities. New York Law imposes a duty on you to become apprised of, and understand, the risks inherent in the sport of skiing, which are set forth above, so that you make an informed decision whether to participate in skiing notwithstanding the risks. New York law also imposes additional duties upon you, to which you must adhere, for the purpose of avoiding injury caused by any of the risks inherent in skiing.

ASSUMPTION OF RISK: I have read and understand the NOTICE above. I have read, reviewed and understand the WARNING TO SKIERS printed above. In signing the Season Pass Terms & Conditions of Purchase and using the season pass, I signify that I am aware of and understand the risks inherent in the sport of skiing and that I am accountable for my action as set forth on the WARNING TO SKIERS signs. I agree that this acknowledgement shall be for the entire term of the season pass. For the entire term, I relinquish my right to a refund of the purchase price of the pass purchased that is allowable under the Safety in Skiing Code for those persons unwilling to ski because of the risks of the sport or the duties imposed upon skiers by law. All pass applicants must sign the Season Pass Terms & Conditions before receipt and/or use of season pass.

Payment Plan

Free financing is available when you purchase your season pass on or before 9/2/2020.

FOR ONLINE PURCHASES: The Home Mountain will charge a minimum of 25% of your total (more if you prefer) on the date of purchase. The remainder will be automatically charged in three equal installments, to occur on the same date as purchased each month following the initial payment. If an initial payment is made on the 31st day of a month, subsequent payments will be on the last day of the months that follow. Financing requires a credit card on file with an expiration date after the last installment date. Should the card used be declined or be canceled during the financing period, the purchaser is responsible for updating the Home Mountain with valid payment, or will forfeit all previous investments, and the season pass will be revoked.

FOR PURCHASES MADE IN PERSON OR OVER THE PHONE: The Home Mountain will charge a minimum of 25% of your total (more if you prefer) on the date of purchase. The remainder will be automatically charged in three equal installments, to occur on the 15th of each month following the initial payment. Financing requires a credit card on file with an expiration date after the last installment date. Should the card used be declined or be canceled during the financing period, the purchaser is responsible for updating the Home Mountain with valid payment, or will forfeit all previous investments, and the season pass will be revoked.
